Notice is hereby given that, pursuant to 40 C.F.R. 51.102, the Florida Department of Environmental Protection (Department) is accepting comments and will hold a public hearing, if requested, on a proposed revision to Florida's State Implementation Plan (SIP) under the Clean Air Act (CAA). The notice of opportunity to submit comments and request a public hearing was published on December 6, 2016, in the Florida Administrative Register. The public hearing, if requested, will be held on January 10, 2017.

This SIP submittal proposes to revise Florida's January 22, 2013 Infrastructure SIP submittal for the 2010 Revised National Ambient Air Quality Standard for Nitrogen Dioxide (NO<sub>2</sub>). This SIP submission is solely meant to address the CAA Section 110(a)(2)(D)(i)(I) prongs 1 and 2 infrastructure elements that the Department did not include in its January 22, 2013 submittal per EPA's November 19, 2012 guidance memorandum.

The public notice and pre-hearing SIP submittal are enclosed. The Department respectfully requests that EPA provide any comments on this submittal by January 5, 2017.
