## 1. SITE LOCATION

1.1 Okaloacoochee Slough (OKS) WMA is located in Hendry County. This project will occur along Otter Grade and Spoonbill Pass (Figure 1).

## 2. GENERAL SCOPE OF WORK

2.1 Contractor will be responsible for providing all labor, services, equipment, tools, materials, mobilization/demobilizations costs, permits and insurance necessary to complete the work.

2.2 Contractor shall use every precaution necessary to prevent pollution of water resources (including ground water) by fuel, oils, chemicals or other harmful materials.

2.3 Equipment shall be thoroughly cleaned of all vegetative debris before entering or reentering the area to reduce the spread of invasive exotic vegetation. The Commission reserves the right to inspect equipment prior to its use on the area.

2.4 Contractor shall remove all extraneous materials and litter associated with the construction from the area.

2.5 Should any historical or cultural artifacts be uncovered during construction activities; the Contractor shall immediately halt construction within that area and notify the Project Manager.

2.6 Any damage to existing state or county property (i.e. roads, culverts, low water crossing, fences, gates, signs trees, or other natural resources) caused by the Contractor and not within the scope of the project work will be the responsibility of the contractor to remedy. Contractor shall be responsible for the conduct of hired personnel while within the project area.

2.7 All construction activities shall be scheduled with the Commission's Project Manager to ensure access to the site and share information about hunting, work projects, and other activities that may be taking place on the area.

2.7.1 No work allowed during quota hunts


2.7.2 Roads must remain open to public driving during quota hunts.

## **3. PROJECT SPECIFICATIONS**

3.1 Figure 1 provides a detailed location of roads to be repaired and widened to support safe, public access on this portion of the WMA. Otter Grade and Spoonbill Pass total approximately 12 miles of unimproved roads that average 8 feet wide. This project will widen the roads to 12 feet to bring them into safe and suitable width for public use by regular 2-wheel drive vehicles. The project includes widening roads to 12 feet, filling pot holes, scraping organics from the roadway footprint, capping (where necessary), spreading and grading road fill material leaving a 4-6% crown, and compact rolling.

3.2 Every effort shall be made by the contractor to avoid damage to native vegetation/wildlife.

3.3 The contractor shall be responsible for the legal disposal of all debris and materials related to this job.

To Whom It May Concern:

Our office reviewed the referenced project in accordance with Chapter 267, *Florida Statutes*, and implementing state regulations, for possible effects on historic properties listed, or eligible for listing, in the *National Register of Historic Places*, or otherwise of historical, architectural or archaeological value.

It is the opinion of this office that the proposed project is unlikely to affect historic properties. However, unexpected finds may occur during ground disturbing activities, therefore we request that the following special condition regarding inadvertent discoveries be followed:

• If prehistoric or historic artifacts, such as pottery or ceramics, projectile points, dugout canoes, metal implements, historic building materials, or any other physical remains that could be associated with Native American, early European, or American settlement are encountered at any time within the project site area, the permitted project shall cease all activities involving subsurface disturbance in the vicinity of the discovery. The applicant shall contact the Florida Department of State, Division of Historical Resources, Compliance and Review Section at (850)-245-6333. Project activities shall not resume without verbal and/or written authorization. In the event that unmarked human remains are encountered during permitted activities, all work shall stop immediately and the proper authorities notified in accordance with Section 872.05, *Florida Statutes*.

Good Morning Laura,

Thank you for sending along this information. So this land is owned by the State of Florida, it was purchased from Alico just last year. The FWC is managing it as a WMA.

With other Water Management Districts, we do not normally go through the permitting process at this stage. We are at the stage of interim management guideline approval. This is an approval process set up by the Acquisition and Restoration Council (ARC) in which we seek approval to proceed. Often this process is exempt from permitting, however if after ARC approval, If any permits are then required, at that stage is when our staff usually pursue that process. Attached are the interim management guidelines for your reference. A virtual meeting would be great to discuss further, as I know every Water Management District has their own process on how to proceed.

Hi Dylan- I'm SO SORRY it took so long to get back with you. I think we are going to need a meeting on this project. Do you have a consultant on contract that can assist you with any required permitting? To aid in our discussion, we need to see a sketch of the proposed road improvements (typical plan view and cross-section), proposed road profile and type of fill materials to be used, and if any wetlands or other surface waters (lakes, ditches, swales) will be impacted and where (and acreage). It's likely that this project will need an Environmental Resource Permit.


I'm assuming that all of the proposed works will be on property owned by the State of Florida, correct? It appears that this project is outside of the boundary of the Okaloacoochee Slough State Forest. I am not very familiar with this site; does FWC manage it as a Wildlife Management Area?

We at the South Florida Water Management District have an overall permit for this property called the Alico NE-PES, for water retention on the site. Are you familiar with this project? The Permit Number is 26-01213-P and can be found on our ePermitting website, at the link below my contact information. Instructions on how to look up permit information on our website are also attached. See screen shot below as well (our permit covers the area outlined in blue). Wetlands information for the overall property can be found in this permit.

I'm not sure if your project could be a modification of this existing permit, or if it needs a separate permit. I will have to consult with the staff who issued this existing permit, and also try to have them in our meeting.

Let us know when you are available to meet, and we can set up a virtual meeting to discuss further.

I am copying Angelica in case she has any other comments or information to add.
