THE FOLLOWING ITEMS ARE REQUIRED

1. Submit Transfer Fee of \$500, as specified in paragraph 62B-56.130(2)(e), F.A.C.
2. Provide evidence that the property owner meets the definition of a responsible entity, pursuant to Rule 62B-56.120(3), 62B56.020(43), F.A.C.
3. Written instrument from financial institution or insurance company demonstrating that financial assurance can be obtained. [Rule 62B-56.050(3)(h), F.A.C.].
4. The proposed responsible entity must meet the requirements of Chapter 62B-56, F.A.C., and if applicable the terms and conditions of the existing permit, including the financial assurances required under Rule 62B-56.090, F.A.C.
5. Any person signing this agreement in the capacity of corporate officer, partner, public official, or any other similarly designated representative should include the title of their position and the name of the organized body that they represent in the space provided (below) for the printed or typed name of the new responsible entity.

Note: For an agent to represent the new responsible entity in other matters pertaining to the permit, the authorization located on page two of this form must also be completed.

A permit transfer cannot occur until the property is sold, the change of ownership has been recorded, the permit transfer fee has been processed, and the Department confirms that the proposed responsible entity meets the provisions provided under Permit Transfers, Section 62B-56.120, Florida Administrative Code (F.A.C.), and Financial Assurance 62B-56.020(5), F.A.C. No construction by the new responsible entity is authorized until the Department approves the permit transfer agreement and the approved permit transfer agreement is posted on the site

Additionally, the responsible entity, as authorized by the department, is required to comply with the terms and conditions of the permit and may be liable for any corrective actions required because of any violations of the permit prior to the approval of the transfer by the Department. All construction must conform strictly to the requirements of the permit.

Should the new owner/responsible entity propose changes in the authorized work, the Department must approve the changes in writing prior to their implementation. Copies of the permit and approved construction plans (if any) should be obtained from the previous owner.
