The Agency Term Contract No. «gc» (hereinafter "Contract") between the FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (hereinafter "Department") and «atc_name» (hereinafter "Contractor") executed on «orig_contract_date», to provide petroleum contamination site response action services in the «region» Region, is hereby amended.

WHEREAS, the Department has solicited, received, negotiated and accepted rates for the two new pay items identified; and

WHEREAS, the Effective Date of the Revised Pay Items shall be September 15, 2018. However, outstanding Work Assignments prior to this date shall continue and be subject to requests for change, as appropriate; and

WHEREAS, the pay item changes authorized will be applicable only for new work assignments offered on or after the Effective Date of September 15, 2018 ("New Work" assignments).

NOW THEREFORE, the parties agree as follows:

1. The following provision is hereby added to paragraph 37, Disqualification:
 - E. Contractor certifies that it is not on the Scrutinized Companies that Boycott Israel List or engaged in a boycott of Israel. Pursuant to Section 287.135, F.S., the Department may immediately terminate this Contract at its sole option if the Contractor is found to have submitted a false certification; or if the Contractor is placed on the Scrutinized Companies that Boycott Israel List or is engaged in the boycott of Israel during the term of the Contract. As provided in Subsection 287.135(8), F.S., if federal law ceases to authorize these contracting prohibitions then they shall become inoperative.
2. Department hereby modifies Attachment A (V2.0), Scope of Services, Section V. Technical Specifications, Subsection B. Schedule of Pay Items, and Attachment D, Rate Schedule (V«previous_attach_d»), as follows:
 - i. Pay Item 14-1, Direct Push Boring with In-Situ Injection: [Per Foot] is superseded with Pay Item 14-1.a., Direct Push Boring with In-Situ Injection: [Per Day] for all New Work assignments offered on or after September 15, 2018.
 - ii. Pay Item 14-2, In-Situ Injection Into Existing Well/Treatment Point: [Per Injection Point] is superseded with Pay Item 14-2.a., In-Situ Injection Into Existing Well/Treatment Point: [Per Day] for all New Work assignments offered on or after September 15, 2018.
3. All New Work assignments offered prior to September 15, 2018, will continue to apply Contractor's applicable prior Rate Schedule.

4. Contractor’s Rate Schedule is hereby changed for the Pay Items indicated on Tables 1 and 2 below, effective for New Work assignments unless and until further modified by a subsequent amendment to the Contract.
5. This amendment modifies only the pay items and rates as specified on Tables 1 and 2, and does not add, delete or otherwise modify any other line item contained in the contract.
6. Attachment D, Rate Schedule (V3.0) is hereby added to the Contract and attached hereto and made a part hereof. For all New Work assignments offered on or after the Pay Item Change Date established in this Amendment, Attachment D, Rate Schedule (V3.0) shall apply.
7. All other terms and conditions of the Contract remain in effect. If and to the extent that any inconsistency may appear between the Contract and this Amendment, the provisions of this Amendment shall control.
