Abandoned Tank Restoration Program (ATRP)

Who should file an Application?

Any owner of a facility where the storage of petroleum products for consumption, use, or sale at the facility ended on or before March 1, 1990, and there is petroleum product contamination from abandoned petroleum storage system(s) for which a state funded cleanup is being requested should complete the ATRP Application and the Certification forms and send to:

The Florida Department of Environmental Protection (Department) will review your application and determine eligibility for the ATRP. A facility inspection may be required in order to verify eligibility. The Department will send you a written decision upon completion of this review, along with further instructions regarding facility cleanup procedures. Submission of this form does not guarantee that you will receive state funding assistance.

Instructions for completing the ATRP Application - (Use an "X" if the answer is unknown)

Fill in the name and physical address of the facility.

Fill in the name and mailing address of the current real property owner.

Optional - Fill in the current real property owner's phone numbers and email address.

Enter the date when contamination was discovered at the facility. A Discharge Reporting Form must be filed with the Department's contracted local program or the Department's District Office in which the facility is located. Petroleum contamination from the abandoned petroleum storage system must be verified for eligibility in this program.

Enter the date the facility last stored petroleum products for consumption, use or sale, and provide supporting documentation that this site ceased conducting business involving consumption, use, or sale of petroleum products at the facility on or before March 1, 1990. Such documentation could be a combination of, but is not limited to:

- dated aerial photographs
- dated site photographs
- historical telephone directories
- historical city or suburban directories
- dated government permits (building occupancy, licenses, construction, etc.)
- local or state tax invoices or receipts
- dated business documents or receipts (Articles of Incorporation, etc.)
- business contracts with suppliers
- employment records

Have the petroleum storage system(s) been properly closed and if so, provide the date. Must comply with the Department's petroleum storage system closure requirements pursuant to Rules 62-761.800(2) and 62-762.801(2).

If you are financially unable to comply with the Department's petroleum storage system closure requirements the Department will request and you must provide financial documents that show the facility owner is financially unable to comply with the petroleum storage system closure requirements. The Department will take into consideration the owner's net worth and economic impact.

Provide the DEP Facility number if known. If the facility is not registered, information on the storage tanks is required and the Department will assign a facility number.

Fill in the table with each tank at the facility, a second page is available if necessary.

Sign and date application.

Complete and sign the ATRP Certification form.

Return both forms to the Eligibility Coordinator at the address listed above.
