I. Cooperative Agreement Overview

The Florida Department of Environmental Protection's (FDEP) CERCLA Site Screening (CSS) team works within the Brownfields and CERCLA Site Screening Section and conducts research and assessments of sites with confirmed and/or suspect contamination for the U.S Environmental Protection Agency's (EPA) Superfund program. Currently, the EPA provides funding for this work through Cooperative Agreement (CA) Number V-00D57717, which allows FDEP to perform site assessments including prescreening evaluations, abbreviated assessments, reassessments, preliminary assessments with or without sampling, and more detailed site inspections including sampling.

On August 16, 2017, the FDEP was awarded a total of \$631,340 for a two-year period from October 1, 2017 to September 30, 2019 via CA V-00D57717. This CA amounts to \$313,220 for fiscal year (FY) 2018, and \$318,120 for FY 2019. A portion of the FY 2018 monies (\$172,271 or 55%) were released in August 2017. The remaining 45% of the FY 2018 monies (\$140,949) and a portion of the FY 2019 monies (\$174,966 or 55%) were released in July 2018. The FDEP decided not to request the remaining 45% of the FY 2019 monetary award amount (\$143,154) that was scheduled to be released in June 2019 and continued to conduct work utilizing the total budget amount of \$488,186. The rejection of additional funds was attributable to a slower-thannormal start to FY19 sitework due to the inability to obtain Site Access Agreements (SAA) with property owners/responsible parties, as well as an unexpected government shutdown which put a halt on required reviews by EPA staff, as well as FDEP staff vacancies.

This report outlines the commitments accomplished during the entire CA period from October 1, 2017 to September 30, 2019 and represents the final report for CA V-00D57717.

II. Status of Staff

Staff changes reported during this CA timeframe included the departure of Padraic Conner (ESIII) during the 2nd Quarter, the departure of Carrie Kruchell (Environmental Manager) and Hope Cates (ESIII) during the 3rd Quarter, and the retirement of Jim McCarthy (Professional Geologist II) during the 4th Quarter of FY 2019. Kelly Crain was hired as the Environmental Manager and started in her position on September 23, 2019. Ginger Shirah was hired as an ESIII and Meredith Garren was hired as an ESI starting their positions during the 1st Quarter of FY 2020, under the new CA. **Table 1** (below) gives an overview of current CSS staff as of the date of this report.

VI. Other Tasks in Support of Assessment Activities

Keith McClain, Office Automation Specialist for CSS, prepares Geographic Information System maps and generates tables for CSS deliverable reports. However, his position is funded under a separate source and not included in the "others" category.

Non-site-specific Activities presents the total hours spent for all other assessment functions including, but not limited to: technical assistance, training, public requests, workshops, quarterly EPA reports, work plan amendments, fiscal tracking, geology boilerplates, EPA backlog sites, public inquiries and complaints, travel for meetings and trainings (when approved), time sheet entries, staff meetings, administrative duties, vacancy recruitment, interviews and presentation preparations.

For FY 2018, 697 hours were spent on non-site-specific activities by Megan Johnson, Jim McCarthy, Padraic Conner, and Hope Cates. For FY 2019, 554 hours were spent on non-site-specific activities by Megan Johnson, Justin Cross, Carrie Kruchell, Jim McCarthy, Padraic Conner, and Hope Cates.

VII. Budget

As stated earlier in Section I, the total approved funding award for CA V-00D57717 was \$631,340; however, the FDEP decided not to accept the final allotment amount of \$143,154 based upon the inability to utilize those additional funds as discussed earlier in this report. As of September 30, 2019, \$47,090.85 remains in the CER17 overall grant budget.

The details of the budget and expenditures for CER17 as of September 30, 2019, are shown below in Table 5.
