- Set record number of adopted sea turtle nests (60) to fund interns and project supplies for the Reserve's turtle program. 142 nests were identified and protected against predation, resulting in 7,122 emerged hatchlings!
- Hired the inaugural Norris Gaynor Student Scholarship Fellow through a generous \$150K donation. The fellow assisted the Reserve's Education department reach a record 2,680 participants during National Estuaries Week.
- Installed the first permanent art installation in a prominent Naples Park to increase community awareness of Friends of Rookery Bay and Rookery Bay National Estuarine Research Reserve.

FORB's leadership in eco-tourism is especially noteworthy and their ecotour provider has provided a leadership example of public education.

  - FORB continues to be a critical partner to Rookery Bay to further our management mission. FORB provides opportunities, support and resources that would otherwise be unavailable to the Reserve.

  - Despite extreme challenges from the pandemic, the board was able to rapidly pivot its annual plan to a virtual format and develop successful outreach and fundraising campaigns.

  - FORB has been a CSO for over 30 years and their board and membership are deeply devoted to the mission of Rookery Bay.

**CSO President’s Comments on the CSO & ORCP Relationship and Support:**

*Although we are a non-profit organization, our obligations to the state and the CSO are onerous and often bureaucratic. It is what it is. For the state to require a Yellow Book Audit of an organization this small is unreasonably costly and unproductive. We drove our finances to the ground to pay for this, thus robbing the Reserve funds that could be better used for education and research. I understand this is a result of previous CSOs who misbehaved, but it serves no one to punish everyone. Although I am appreciative of the generous support of the Reserve staff, I am disappointed not to hear from state officials about the effort we are putting forth.*

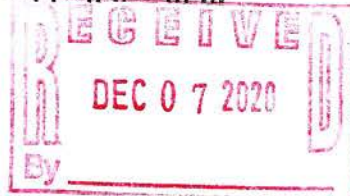
