**CSO's Mission:** *Consistent with your Articles and Bylaws*

Our mission is to promote the mission of the Apalachicola National Estuarine Research Reserve and to provide citizen support for resource protection, education, and research.

Our Reserve's Nature Center has been closed from March of last year and we have plans to hopefully open in May. This said, we were still able to offer classes for Franklin County Schools through zoom for Estuary's day. Classroom presentations were still presented to Pre-K at the Franklin County School and Apalachicola Bay Charter School and field trips to the Reserve were offered for 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, and 7<sup>th</sup> grade classes. We also supported the Turtle Adopt a Nest program which is a big fundraiser for the St. George Island Sea Turtle program. We produced income from donations and membership dues. In coordination with the Franklin County Master Gardeners, we supported the Bay Friendly Yards awards and were able to set up seed packet donations for the three libraries in Franklin.

We are going to renew giving a yearly luncheon for the Chamber of Commerce. We would also like to offer to our area, Migratory Bird Walks. This first year, we will start with developing a program with talks and walks during the spring and fall to see migratory birds on the Reserve Trails. The second year we would develop educational lectures and walks about the diverse avian life here by expanding the walks to other sites such as the Apalachicola trail and St. George Island Trails. The third year, FOR and the Chamber of Commerce would get together and plan a nationally advertise Migratory Bird Weekend for our area because this is one of the best places in North America to see migratory birds.

The Friends are excited to have the Nature Center open again as the gift shop is the primary source of funding for the CSO. As more groups are coming back to the Reserve, this offers more opportunities to build stewardship within the local community and the tourists that visit Franklin County. The natural surroundings of this special place are the key aspect of why so many people visit this area. The Friends, working in concert with the Reserve, support every aspect of protecting species, safeguarding natural resources and exploring restoration of degraded areas.

- *Effectiveness of the organization in fulfilling their purpose to support the managed area(s).*

The board touches all parts of the Reserve, from research to education. The board members volunteer a considerable amount of time assisting with citizen science projects, assisting with monitoring, participating in outreach and training events, and school trips. The Friends board members actively participate in the Reserve Advisory Committee and other special events such as the Research Symposium.

- *Effectiveness of the Board of Directors in completing their Annual Program Plan.*

The Board of Directors were incredibly effective in completing their annual program plan and support all of the programs of the Reserve throughout the last year despite the pandemic. As there were no revenues coming in due to the Gift shop being closed, the Friends Board were quick to evaluate their financial standing mid-year to ensure that program support could continue.

- *The relationship between ORCP and CSO What went well? Are there areas of improvement?*

The FOR Board is very supportive of the Reserve and each of its programs. If the Reserve has a need not met by state or federal funding, the Friends do their due diligence to ensure that spending is aligned with the mission of the Reserve and the Friends. The Reserve does its best to present these needs during regular board meetings, but if something important comes up between meetings, the board members are very responsive and often we are able to move forward quickly. FOR acts as the fiscal agent for the Reserve when monies are given to ANERR from an outside entity, which makes purchasing much simpler.

Communications are very strong between the Reserve and the Friends, with the Executive Director available on site several days a week. For example, the board was informed of the opening of the Nature Center weeks ahead of the possible date. FOR volunteers were ready and trained, merchandise was ordered, and we were all ready for opening day.

We have an excellent relationship with the NERR staff. Jenna, the manager of the Reserve, attends all our meetings and updates the Board on all events and needs at every meeting. I cannot think of anything that could be improved on this relationship after going through both Hurricane Michael and COVID as a team.



## CODE OF ETHICS

### PREAMBLE

- (1) It is essential to the proper conduct and operation of Friends of the Reserve, Inc. (herein "CSO") that its board members, officers, and employees be independent and impartial and that their position not be used for private gain. Therefore, the Florida Legislature in Section 112.3251, Florida Statute (Fla. Stat.), requires that the law protect against any conflict of interest and establish standards for the conduct of CSO board members, officers, and employees in situations where conflicts may exist.
- (2) It is hereby declared to be the policy of the state that no CSO board member, officer, or employee shall have any interest, financial or otherwise, direct or indirect, or incur any obligation of any nature which is in substantial conflict with the proper discharge of his or her duties for the CSO. To implement this policy and strengthen the faith and confidence of the people in Citizen Support Organizations, there is enacted a code of ethics setting forth standards of conduct required of Friends of the Reserve, Inc. board members, officers, and employees in the performance of their official duties.

### STANDARDS

The following standards of conduct are enumerated in Chapter 112, Fla. Stat., and are required by Section 112.3251, Fla. Stat., to be observed by CSO board members, officers, and employees.

#### **1. Prohibition of Solicitation or Acceptance of Gifts**

No CSO board member, officer, or employee shall solicit or accept anything of value to the recipient, including a gift, loan, reward, promise of future employment, favor, or service, based upon any understanding that the vote, official action, or judgment of the CSO board member, officer, or employee would be influenced thereby.

#### **2. Prohibition of Accepting Compensation Given to Influence a Vote**

No CSO board member, officer, or employee shall accept any compensation, payment, or thing of value when the person knows, or, with reasonable care, should know that it was given to influence a vote or other action in which the CSO board member, officer, or employee was expected to participate in his or her official capacity.

#### **3. Salary and Expenses**

No CSO board member or officer shall be prohibited from voting on a matter affecting his or her salary, expenses, or other compensation as a CSO board member or officer, as provided by law.

### **1. Prohibition of Misuse of Position**

A CSO board member, officer, or employee shall not corruptly use or attempt to use one's official position or any property or resource which may be within one's trust, or perform official duties, to secure a special privilege, benefit, or exemption.

### **2. Prohibition of Misuse of Privileged Information**

No CSO board member, officer, or employee shall disclose or use information not available to members of the general public and gained by reason of one's official position for one's own personal gain or benefit or for the personal gain or benefit of any other person or business entity.

### **3. Post-Office/Employment Restrictions**

A person who has been elected to any CSO board or office or who is employed by a CSO may not personally represent another person or entity for compensation before the governing body of the CSO of which he or she was a board member, officer, or employee for a period of two years after he or she vacates that office or employment position.

### **4. Prohibition of Employees Holding Office**

No person may be, at one time, both a CSO employee and a CSO board member at the same time.

### **5. Requirements to Abstain From Voting**

A CSO board member or officer shall not vote in official capacity upon any measure which would affect his or her special private gain or loss, or which he or she knows would affect the special gain or any principal by whom the board member or officer is retained. When abstaining, the CSO board member or officer, prior to the vote being taken, shall make every reasonable effort to disclose the nature of his or her interest as a public record in a memorandum filed with the person responsible for recording the minutes of the meeting, who shall incorporate the memorandum in the minutes. If it is not possible for the CSO board member or officer to file a memorandum before the vote, the memorandum must be filed with the person responsible for recording the minutes of the meeting no later than 15 days after the vote.

### **6. Failure to Observe CSO Code of Ethics**

Failure of a CSO board member, officer, or employee may result in the removal of that person from their position. Further, failure of the CSO to observe the Code of Ethics may result in the Florida Department of Environmental Protection terminating its Agreement with the CSO.
