## ***Beach Program Appropriations for FY 2019-2020***

The Florida Department of Environmental Protection (DEP) Beach Management Funding Assistance Program's (BMFAP) Fiscal Year (FY) 2019-2020 Local Government Funding Request (Funding Request) submitted to the Florida Legislature on February 4, 2019, contained a total of nearly \$75.5 million in applications from local governments to conduct beach erosion control projects. Approved applications were presented in the Funding Request on either the Beach Management List or the Inlet Management List. The Beach Management List contained the Beach Restoration and Nourishment Projects in priority order with a separate list of Post-Construction Monitoring projects. The Inlet Management List contained sand bypassing and Inlet Management Plan (IMP) implementation projects with a separate list of post-construction monitoring projects.

In FY 2019-2020, DEP received a new appropriation of \$50,000,000 for beach and inlet projects listed in the Funding Request, per Chapter 2019 -115, Laws of Florida, GAA Line Item 1695:

From the funds in Specific Appropriation 1695, \$40,185,070 in recurring funds from the Land Acquisition Trust Fund and \$9,814,930 in nonrecurring funds from the General Revenue Fund are provided for the Department of Environmental Protection's Beach Management Funding Assistance Program (BMFAP) Local Government Funding Requests for Fiscal Year 2019-2020 pursuant to section 161.101, Florida Statutes, for Beach Restoration/Nourishment and Inlet Sand Bypassing/Inlet Management Plan Implementation Projects Lists.

Funds in Specific Appropriation 1695 shall be provided for Beach Restoration and Nourishment projects on the Fiscal Year 2019-2020 list, in priority order.

Funds in Specific Appropriation 1695 shall be provided for Inlet Sand Bypassing and Inlet Management Plan Implementation projects including post-construction monitoring, in priority order, based on the amount of inlet funding requested as a percentage of the total statewide funding requested, or 10% of the total appropriation, whichever is greater.

Funds in Specific Appropriation 1695 shall be provided for post-construction monitoring projects for Beach Restoration/Nourishment and Inlet Sand Bypassing/Inlet Management projects, to be cost-shared equally, in the BMFAP.

Any remaining unencumbered surplus funds shall be available for beach and inlet management projects in continued priority order, based on readiness to proceed.

All projects that applied for funding in the FY 2018-2019 Funding Request are listed in the following tables. The beach projects are listed in *Table 1*. The beach post-construction monitoring is listed in *Table 2*. The inlet projects are listed in *Table 3* and the inlet post-construction monitoring is listed in *Table 4*. Those projects that did not receive funding are shown with their request and no funding under the column labeled "Amount Appropriated (State Share)."

**Update: Beach Program Appropriations for FY 2018-2019**

DEP’s FY 2017-2018 Funding Request, submitted to the Florida Legislature on December 22, 2017, contained a total of nearly \$57 million in applications from local governments to conduct beach erosion control projects. Approved applications were presented in the Funding Request on either the Beach Management List or the Inlet Management List. The Beach Management List contained the Beach Restoration and Nourishment Projects in priority order, with a separate list of Post-Construction Monitoring projects. The Inlet Management List contained sand bypassing and Inlet Management Plan (IMP) implementation projects with a separate list of post-construction monitoring projects.

In FY 2018-2019, DEP received a new appropriation of \$50,000,000 for beach and inlet projects listed in the Funding Request, per Chapter 2018-009, Laws of Florida, GAA Line Item 1597:

From the funds in Specific Appropriation 1597, \$29,493,889 in recurring funds and \$20,506,111 in nonrecurring funds are provided for the Department of Environmental Protection's Beach Management Funding Assistance Program (BMFAP) Local Government Funding Requests for Fiscal Year 2018-2019, pursuant to section 161.101, Florida Statutes, for Beach Restoration/Nourishment and Inlet Sand Bypassing/Inlet Management Plan Implementation Projects Lists. Funds in Specific Appropriation 1597 shall be provided for Beach Restoration and Nourishment projects on the Fiscal Year 2018-2019 list, in priority order. Funds in Specific Appropriation 1597 shall be provided for Inlet Sand Bypassing and Inlet Management Plan Implementation projects including post-construction monitoring, in priority order, based on the amount of inlet funding requested as a percentage of the total statewide funding requested. Funds in Specific Appropriation 1597 shall be provided for all post-construction monitoring projects for Beach Restoration/Nourishment and Inlet Sand Bypassing/Inlet Management projects, to be cost-shared equally, in the BMFAP. Any remaining unencumbered surplus funds shall be available for beach and inlet management projects in continued priority order. Funds in Specific Appropriation 1597 shall not be provided for any activities related to beach nourishment utilizing offshore sand sources from Martin and St. Lucie counties for the Dade County Shore Protection Project. Any funds in Specific Appropriation 1597 to the Surfside Segment/Dade County Shore Protection Project included in the Department of Environmental Protection's Beach Management Funding Assistance Program Fiscal Year 2018-2019 Local Government Funding Requests may only utilize upland sand sources.

**Update: Beach Program Funds for Hurricane Appropriations**

DEP develops hurricane recovery plans to quantify the damages caused by storms, recommend storm repair strategies and estimate anticipated costs for repairs. These plans outline management strategies that incorporate on-going and emergency federal, state, and local efforts to repair and restore the hurricane related damages to beaches and dunes that are vital to Florida’s health, safety, and economic welfare. The reports are intended to supplement the BMFAP’s Funding Request, which prioritizes the recurrent beach and inlet management projects designed to address the statewide long-term, comprehensive management strategies planned for the next fiscal year.

**2017 Hurricane Season**

During the 2017 hurricane season, Hurricane Irma caused significant damages to the Florida Keys, Gulf of Mexico, and Atlantic Coast beaches. A new appropriation of \$11,198,282 was provided by the Legislature to assist counties with sand replacement associated with Hurricane Irma, per Chapter 2018-009, Laws of Florida, GAA Line Item 1594:

The nonrecurring funds in Specific Appropriation 1594 are provided for the purpose of implementing beach and dune repair and restoration projects in response to the damages caused by Hurricane Irma. These funds shall be placed in reserve until October 1, 2018, when they will be available as state match to federal funds. The department is authorized to submit budget amendments on or after October 1, 2018, to request the release of funds pursuant to the provisions of chapter 216, Florida Statutes. The funds shall be used as necessary state

match to federal funds, or otherwise provide for up to 50 percent of the beach and dune restoration costs where federal assistance is not provided. Counties impacted by Hurricane Irma that are interested in receiving this funding must submit a detailed scope of work to the Beach Management Funding Assistance Program before October 1, 2018. In evaluating this funding, the Department shall prioritize state match to federal funds and proportionately distribute the remaining funds among the areas most critically impacted by Hurricane Irma.

The legislation provided this funding as a match to federal funds, or otherwise up to 50 percent of beach and dune restoration costs, where federal assistance is not provided. The BMFAP completed its review of the requests for Hurricane Irma supplemental funding. Projects which applied for federal funding were given priority; however, sufficient state funds were also available for storm repair projects without federal funding.

The Hurricane Irma supplemental funding requests from impacted coastal communities included assessments for sand replacement and dune revegetation, post-storm surveys, and engineering and design. There were 17 federal projects (Table 9) and four non-federal projects (Table 10). A budget amendment is pending approval before funds can be contracted.

## ***Funding, Accountability and Transparency Reporting***

In Laws of Florida, Chapter 2019-122, subsection (20) of section 161.101, Florida Statutes was amended to read:

“The department shall maintain active project lists, updated at least quarterly, on its website by fiscal year in order to provide transparency regarding those projects receiving funding and the funding amounts and to facilitate legislative reporting and oversight. In consideration of this intent:

(a) The department shall notify the Executive Office of the Governor and the Legislature regarding any significant changes in the funding levels of a given project as initially requested in the department’s budget submission and subsequently included in approved annual funding allocations. The term “significant change” means a project-specific change or cumulative changes that exceed the project’s original allocation by \$500,000 or that exceed 25 percent of the project’s original allocation.

1. Except as provided in subparagraph 2., if there is surplus funding, the department must notify and provide supporting justification to the Executive Office of the Governor and the Legislature to indicate whether surplus dollars are intended to be used for inlet management projects pursuant to s. 161.143 or for beach restoration and beach nourishment projects, offered for reversion as part of the next appropriations process, or used for other specified priority projects on active project lists.

2. The department may use surplus funds for projects identified in subparagraph 1. that do not have a significant change. The department must post the uses of such funds on the project listing web page of its website. The department is not required to post any other notice or supporting justification before it uses the surplus funds for a project that does not have a significant change.

(b) The department shall prepare a summary of project activities, their funding status, and changes to annual project lists for the current and preceding fiscal year. The department shall include the summary with the department’s submission of its annual legislative budget request.

(c) Funding for specific projects on annual project lists approved by the Legislature must remain available for such projects for 18 months. A local project sponsor may at any time release, in whole or in part, appropriated project dollars by formal notification to the department. The department, which shall notify the Executive Office of the Governor and the Legislature of such release and notification must indicate in the notification how the project dollars are recommended to be used after such release.
