The Beach Management Funding Assistance Program (Program) is developing its annual prioritized list of beach and inlet management projects for the Department's FY 2020-2021 Local Government Funding Request (LGFR). The deadline to submit LGFR applications is July 31, 2019.

For the FY 2020-2021 LGFR applications, please make note of the following:

- Funding application forms are provided as Adobe Acrobat PDF-fillable forms.

- For Recreational and Economic Benefits points, please provide the webpage link to the current hotel, motel, or resort condominium license from the Department of Business and Professional Regulation webpage. - A draft copy of the local sponsor's resolution of support is required with the application by July 31, 2019. The deadline for submittal of the signed resolution from the local governing board is **September 27, 2019.**

- For projects that will be requested for funding, please provide the most recent physical monitoring survey data in advance of the LGFR application deadline. The survey data is needed to begin coastal engineering assessments. Please send survey data to:
