## INNOCENT VICTIM PETROLEUM STORAGE SYSTEM RESTORATION PROGRAM (IVPSSRP)

### Who should file this Application?

An owner of a contaminated site acquired prior to July 1, 1990, which ceased operating as a petroleum storage or retail business prior to January 1, 1985, and there is petroleum product contamination from a petroleum storage system(s) for which a state funded cleanup is being requested should complete this application and send to:

The Florida Department of Environmental Protection (Department) will review your application and determine eligibility for the IVPSSRP. A facility inspection may be required in order to verify eligibility. The Department will send you a written decision upon completion of this review, along with further instructions regarding facility cleanup procedures. Submission of this application does not guarantee that you will receive state funding assistance.

### Instructions for completing the IVPSSRP Application - (Use an "X" if the answer is unknown)

Fill in the name and physical address of the facility.

Fill in the name and mailing address of the current real property owner, if different.

Fill in current real property owner's phone numbers and email address.

Fill in the date the current real property owner acquired the property (title taken).

Give the date when contamination was discovered at the facility. A Discharge Reporting Form must be filed with the Department's contracted local program or the Department's District Office in which the facility is located. Petroleum contamination from the petroleum storage system must be verified for eligibility in this program.

Give the date the facility last stored petroleum products for consumption, use or sale. Please provide tangible evidence that this site ceased operating as a petroleum storage or retail business prior to January 1, 1985. Such evidence could be a combination of, but is not limited to:

- dated aerial photographs
- dated site photographs
- historical telephone directories
- historical city or suburban directories
- dated government permits (building occupancy, licenses, construction, etc.)
- local or state tax invoices or receipts
- dated business documents or receipts (Articles of Incorporation, etc.)
- business contracts with suppliers
- employment records

Give the date the petroleum storage system(s) were properly closed. Must comply with the Department's petroleum storage system closure requirements.

Give the DEP Facility number if known. If the facility is not registered, information on the storage tanks is required and the Department will assign a facility number.

Sign and date application. Provide any supporting documentation on contamination, property ownership, and date the tanks were last used or last stored petroleum product.
