What is Map Direct?

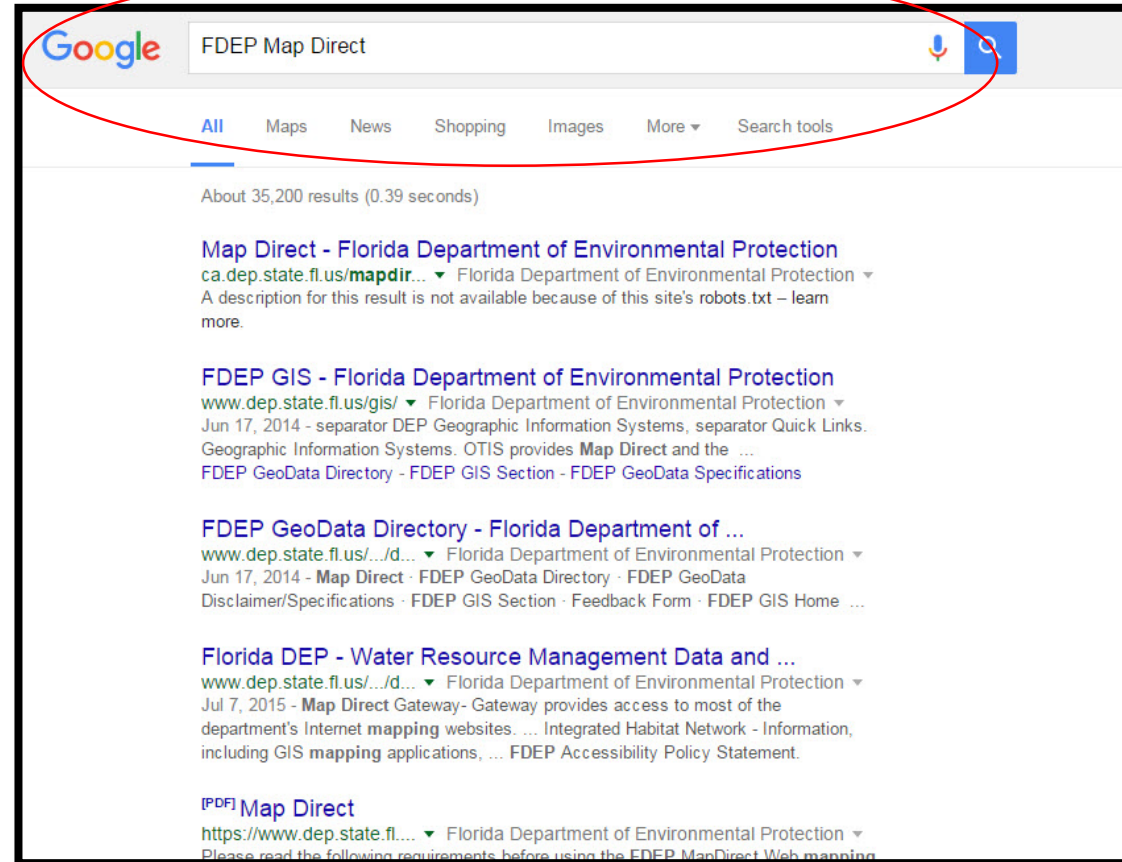
- Web based application that allows you to research if DEP has information regarding a property and/or other properties nearby.
- Can be used to access certain information using links to Oculus.

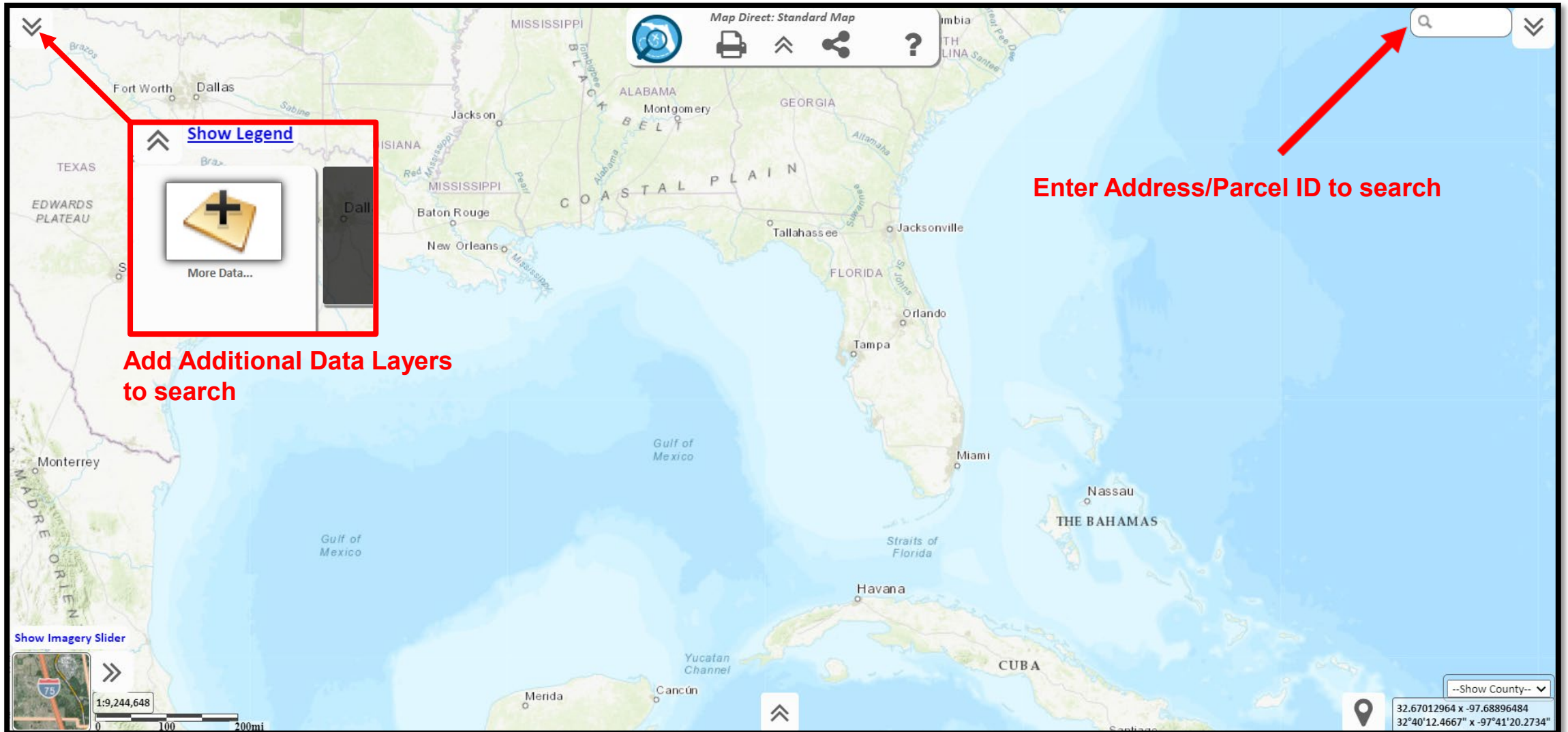



Adding Layers

No layers are preloaded, you must select at least one.

- **Scroll down to view all available layers.**
- **Search for layers by program (e.g., ERP, Waste, Potable Water).**
- **Click “Add Layer to Map” to select.**
- **Add/remove as many layers as needed.**

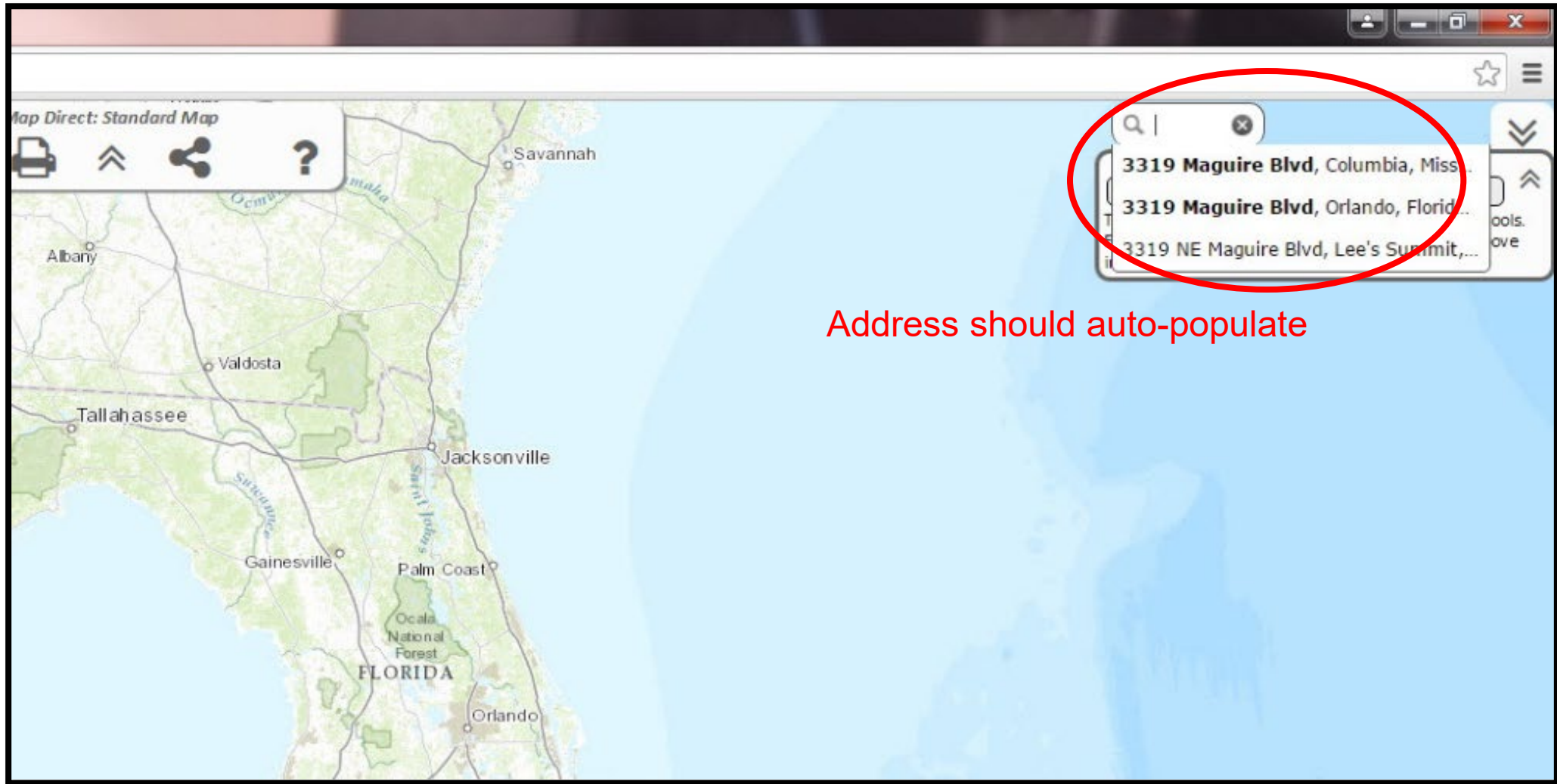

Address should auto-populate



Searching for Address

- **Search for a specific location using address, County, Parcel ID or latitude/longitude.**
 - **When using Parcel ID, first add the “Cadastral 20xx” (Property Appraiser Parcels) layer but do not include dashes.**
- **Search for additional data layers by using the *Add More Data* to map feature.**
- **Once all data layers are added and visible, run the *Area of Interest* report by selecting “*What’s Nearby.*”**



Drop Marker

- **When using the Drop Marker feature, the address identified on the map may not be accurate.**
- **Click on surrounding properties and verify physical address or parcel id number.**
- **Once identified, click on the center of the property and select the “Drop Marker” button and name the marker.**
- **Then click “What’s Nearby.”**

Search Radius

- In the Search Radius (Buffer) pop-up, type over the “1” with an area that should cover the property (Remember to start small - e.g., .05).
- Click on Search.
- The red-shaded radius will show whether the selected area is too large or too small.
 - If it is the wrong size, re-run the report by clicking the center of the property and clicking “What’s Nearby” again.

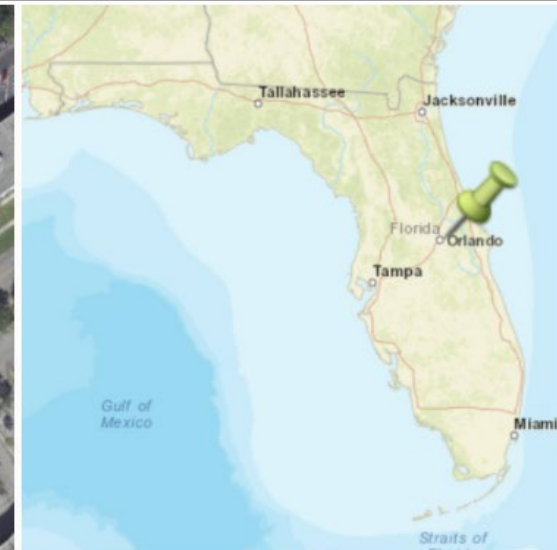

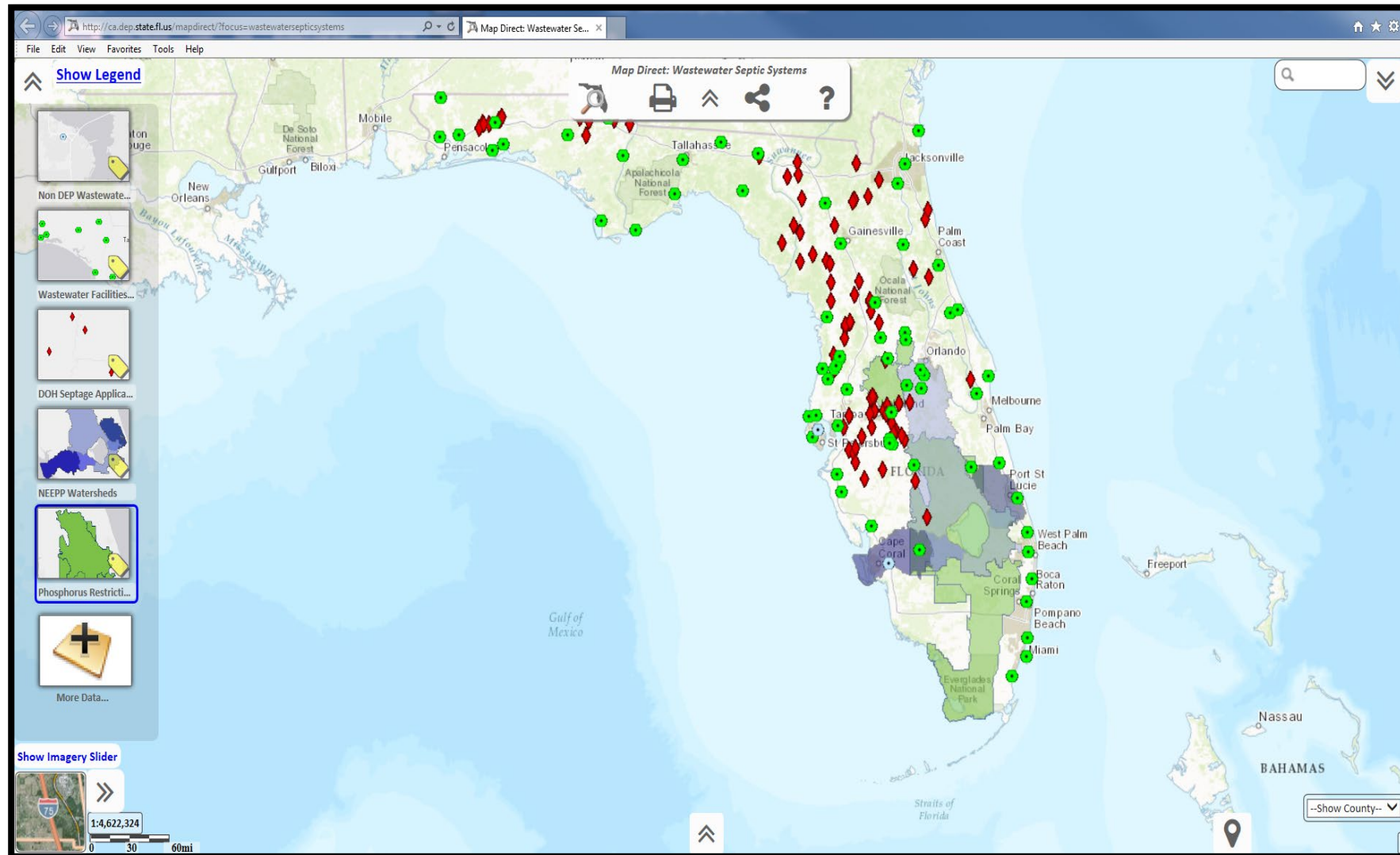
