- Multiple or back to back RFCs can be processed. It is not a requirement that one RFC be approved before another is submitted.
- Be sure all work and costs are preapproved. "After the Fact" RFCs are not allowed.

Sharing Information with Our Contractors

Transport & Disposal of Drummed Waste

Pay items 12-6, 12-13 and 12-15 for T&D of PCW, Soil and Product, respectively, include the drums and labeling per the contract scope of services. If additional drums are required, a request for change must be submitted and approved prior to filling and labeling the drums.

Horizontal/Directional Drilling & Well Installation

The contract does not include pay items for well installation by horizontal (other than by trench) or directional drilling. Costs for these activities are reimbursable with competitive quotes (pay item 22-X).

Ozone Generation/Injection Systems

Due to the specific components and materials required to withstand the corrosive nature of ozone that were not anticipated during solicitation of injection system rates for pay items 14-4 and 14-5, these pay items are not applicable for this purpose. Therefore, ozone generation/injection system costs are reimbursable with competitive quotes (pay item 22-X).

Materials for Connection of Treatment/Discharge Point Stub Ups to Remediation System Manifolds

Materials to connect underground piping stub ups to remediation system manifolds, excluding the manifolds but including risers, hoses, clamps, fittings and struts, are reimbursable with competitive quotes (pay item 22-X) when using the RAC pay items in section 15 of the contract scope of services. However, these materials are "included" in the turn key/all inclusive RA package pay items for pilot testing and short term/episodic system operation in section 16 of the contract scope of services.

New Standardized Quote Forms

New standardized quote forms are available on the PRP Agency Term Contracts (ATC) web site at https://floridadep.gov/waste/petroleum-restoration/content/agency-term-contracts-atc. Please see instructions in the workbook (tab 2). Beginning January 1, 2020, this new form will be mandatory for any quotes to be considered. Valid quotes must be submitted by the subcontractor concurrently to the ATC and the Site Manager as indicated in the header on the form. If the site manager is not copied, the quote will not be considered.
