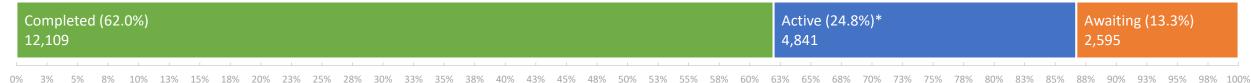

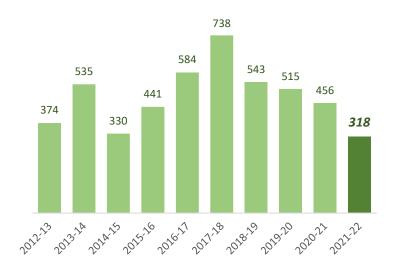

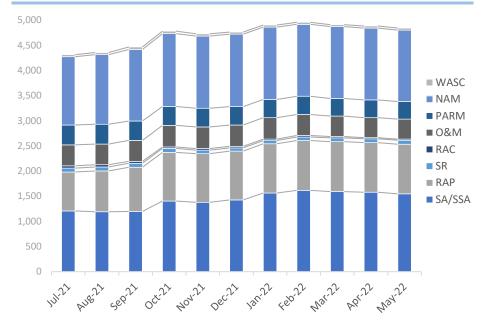

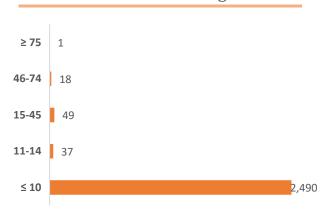
#### Discharge Closures by Fiscal Year

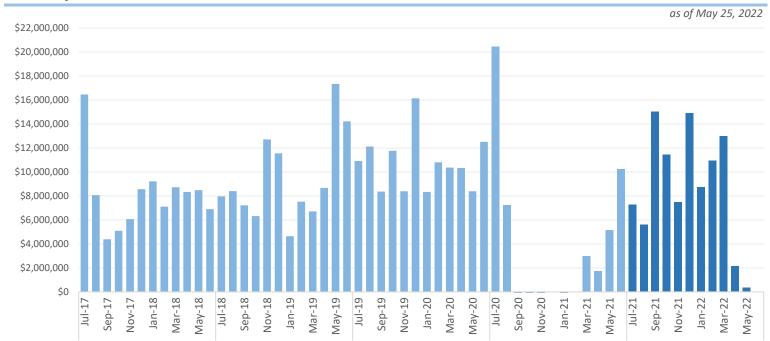

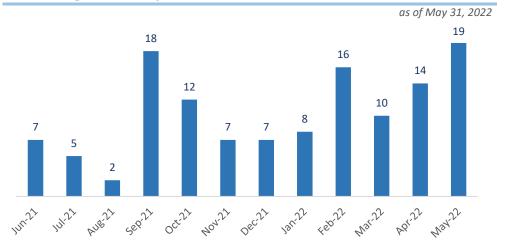

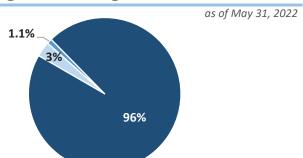
#### Monthly Net Encumbrance Amounts (FY 2017-18 thru present)
