Please be aware that Notices of Rule Development, Notices of Rule Workshops or Hearing, Notices of Proposed Rule, Notices of Change, Notices of Intent to Adopt a Rule, and Notices of Withdrawal pertaining to specific Florida rule sections are published in the Florida Administrative Register (FAR) (available online at www.flrules.org). Although DARM's Air Regulatory Projects Update may coincide with open comment periods for specific rulemaking activities, these updates are not intended to serve as general or specific notice of any pending rulemaking activity or as a substitute for the public notices published in the FAR.

This update lists Florida air rules recently adopted, revised, or repealed, and any Clean Air Act State Implementation Plan (SIP) revisions that DEP may have recently submitted to the U.S. Environmental Protection Agency (EPA).

Updates

Adoption by Reference of EPA Federal Regulations

On November 13, 2024, DEP published a Notice of Intent to Adopt in in the FAR for Rule 62-204.800, F.A.C. The proposed rule amendments will update the Department's adoption by reference of air pollution regulations promulgated by EPA at Title 40, Code of Federal Regulations (C.F.R.), to incorporate requirements of the Department's federally approved and delegated air pollution programs. These rule amendments included adoption of New Source Performance Standards (NSPS) and National Emission Standards for Hazardous Air Pollutants (NESHAP) amendments and streamline adoptions by reference where appropriate.

Operation Permits for Major Sources of Air Pollution: Proposed Revisions to Chapter 62-213, F.A.C. ("Operation Permits for Major Sources of Air Pollution")

On December 5, 2023, DEP published a Notice of Rule Development (NORD) to revise Chapter 62-213, F.A.C. (Operation Permits for Major Sources of Air Pollution"), to update major stationary source state permit regulations for consistency with federal regulations and state program requirements under Title V of the Clean Air Act.

These updates will include removal of the affirmative defense provision, adding a process for making minor amendments to existing permits, and clarifying the actions that constitute off-permit changes to existing permits. Additional revisions will include repealing the Title V Air General Permits rule section in its entirety, as the sources are now regulated under Rule 62-210.310, F.A.C. ("Air General Permits"), clarifying that major sources may operate while under the permit renewal process, and clarifying requirements applicable to facilities that may alternate between authorized methods of operation.

DEP may propose other streamlining, clarifying and corrective revisions for various rule sections in Chapter 62-213, F.A.C.

On November 5, 2024, the Department published a Notice of Proposed Rulemaking (NOPR) to revise Chapter 62-213, F.A.C., based on stakeholder input received during the rule development process. The proposed rule amendments address Operation Permits for Major Sources of Air Pollution. These updates include removal of the affirmative defense provision, adding a process for making minor amendments to existing permits, and clarifying the actions that constitute off-permit changes to existing permits. Additional revisions will include repealing the Title V Air General Permits rule section in its entirety as the sources are now regulated under Rule 62-210.310, F.A.C. ("Air General Permits"), clarifying that major sources may continue to operate while under the permit renewal process, and clarifying requirements applicable to facilities that alternate between authorized methods of operation. The Department is proposing other streamlining, clarifying, and corrective revisions for various rule sections in Chapter 62-213, F.A.C.

Florida's DRAFT Regional Haze Progress Report for the 2nd Implementation Period, October 30, 2024

On October 30, 2024, DEP submitted to the EPA Florida's Draft Regional Haze Progress Report for the 2nd Implementation Period. This proposed draft Regional Haze Progress Report addresses commitments and enforceable actions under Florida's Regional Haze Plan for the Second Implementation Period.

In Florida's Regional Haze SIP (submitted to EPA on October 8, 2021, and supplemented on June 14, 2024 and October 28, 2024), the Department set forth a long-term strategy to attain reasonable progress goals (RPGs) for visibility impairing pollutants in Florida's Class I areas, which include the Chassahowitzka National Wilderness Area, the Everglades National Park, and the St. Marks National Wilderness Area. The predicted reductions in visibility impairment were expected to result from the implementation of a combination of existing emissions control activities and planned emission control programs. Florida's Regional Haze Progress Report is intended to address the requirements of 40 CFR 51.308(g), which requires that states develop and submit to EPA periodic reports evaluating the state's progress goals toward the RPGs applicable to Class I areas within their jurisdictions. Specifically, this draft Progress Report is intended to fulfill the requirements of paragraphs 51.308(g), (h), and (i) of the RHR and to serve as a progress report for the second regional haze planning period, from 2019 to 2028. In this progress report, the Department affirms that the combined elements of Florida's approved regional haze SIP for the first planning period (78 FR 53250) and pending regional haze SIP for the second planning period are adequate for making reasonable progress towards the RHR goal of achieving natural visibility conditions at Class I areas by 2064. Pursuant to 40 CFR 51.308(h), Florida's Progress Report also includes a determination of the adequacy of the State's existing implementation plan.

Asbestos Program: Proposed Revisions to Chapter 62-257, F.A.C. ("Asbestos Program")

On May 7, 2024, DEP published a Notice of Rule Development (NORD). The purpose of this NORD is to revise two rules pertaining to Florida's Asbestos Program – 62-257.200 ("Definitions") and 62-257.301 ("Notification Procedure and Fee"), and to repeal 62-257.400 ("Fee Schedule") and 62-257.900 ("Form"). The revisions will update definitions; clarify the notification procedure; simplify the fee schedule; and amend the Notice of Demolition or Asbestos Renovation Form, and incorporate the Form into Rule 62-257.301, F.A.C.

The Division is proposing to revise Rule 62-257.301, F.A.C., to provide for a simplified, two-tiered fee structure. The two-tiered fee structure will provide for (1) a flat fee of \$200 for any notification that generates a paper invoice (generated either though a paper notification or using DEP's Business Portal); or (2) a discounted flat fee (\$100) if the notification is filed and paid electronically using DEP's Business Portal. These revisions in Rule 62-257.301, F.A.C., will allow the Division to repeal Rule 62-257.400, F.A.C., which contains the current fee schedule that varies the fee depending on the amount of regulated asbestos containing material being removed. This simplified fee structure will reduce costs for the owners or operators of asbestos removal projects.

2024 Hillsborough-Polk Verification of Continued Attainment Draft Annual Report

On May 1, 2024, DEP submitted a draft report version of the annual review of emissions data and air dispersion modeling parameters for Mosaic New Wales and Mosaic Bartow to EPA Region 4. This report verifies continued attainment of the 2010 one-hour sulfur dioxide (SO₂) National Ambient Air Quality Standard (NAAQS) for the Hillsborough-Polk maintenance area in accordance with section 175A of the Clean Air Act. This report includes:

- 1) The status of ongoing compliance with the SO₂ emission limits for the Mosaic New Wales and Mosaic Bartow facilities;
- 2) A review of annual emissions data for these two facilities;

- 3) A review of the air dispersion modeling inputs and assumptions identified by EPA as a result of coordination with the Department;
- 4) A certification that there are no changes in the air dispersion modeling inputs and assumptions that could result in a modeled violation; and
- 5) All supporting documentation and data that the Department evaluated in preparing this annual report.

The draft report addresses the items listed above to demonstrate that the Hillsborough-Polk maintenance area continues to attain the 2010 SO₂ NAAQS.

DEP submitted the final report version to EPA Region 4 on June 12, 2024.

EPA Region 4 approved the report on October 9, 2024.

2024 Florida Ongoing Data Requirements Rule for the 2010 SO₂ NAAQS Draft Annual Report

On May 1, 2024, pursuant to the ongoing data requirements of EPA's DRR rule in 40 CFR 51.1205, DEP submitted a draft annual report to EPA Region 4. This report addresses the areas around two DRR-applicable sources in Florida that EPA designated "Attainment/Unclassifiable" for the 2010 one-hour SO₂ NAAQS, based on modeling of actual SO₂ emissions. The two sources subject to the ongoing data requirements are:

- Jacksonville Electric Authority (JEA) Northside Generating Station; and
- WestRock CP, LLC, Fernandina Beach Mill (WestRock).

The DRR requires that DEP review these areas annually to document the annual SO₂ emissions of each applicable source and determine whether additional modeling is needed to characterize the air quality relative to the 2010 one-hour SO₂ NAAQS. DEP's draft annual report documents SO₂ emissions decreases for both areas.

DEP submitted the final report version to EPA Region 4 on June 12, 2024.

EPA Region 4 approved the report on October 9, 2024.

Florida's Supplemental Amendment to Previously Proposed Regional Haze Plan for the Second Implementation Period

On January 19, 2024, DEP submitted to EPA Florida's Pre-Hearing draft of the Supplemental Amendment to Florida's previously submitted Regional Haze Plan for the Second Implementation Period. This proposed SIP revision addresses regional haze in Florida's mandatory federal Class I areas and nearby Class I areas for the second implementation period under EPA's Regional Haze Rule.

On January 29, 2024, DEP received a written request to extend the comment period and re-schedule the hearing, if requested, to a later date. On February 16, 2024, DEP published in the Florida Administrative Register, a notice of extension of the comment period through March 8, 2024, and rescheduled the hearing, if requested, from February 27, 2024, to March 20, 2024. No meeting was requested.

On March 8, 2024, DEP received written comments from the National Parks Conservation Association, Sierra Club, and the Coalition to Protect America's National Parks. DEP drafted a Response to Comments, which DEP included in the final report.

On June 14, 2024, DEP submitted to EPA Part I to Florida's Final Supplemental Amendment to the previously submitted Regional Haze Plan for the Second Implementation Period.

On October 28, 2024, DEP submitted to EPA Part II to Florida's Final Supplemental Amendment to the previously submitted Regional Haze Plan for the Second Implementation Period.

Florida's State Implementation Plan (SIP) Chapter 62-210, F.A.C. ("Stationary Sources – General Requirements"): Rule Removals and Amendments

On August 15, 2023, DEP submitted to EPA a Final Proposed SIP Amendment. This proposed SIP revision consists of the removal of outdated or superseded rule requirements in Chapter 62-210, F.A.C., ("Stationary Sources – General Requirements"). The proposed SIP revision incorporates amendments to F.A.C. rules to make Florida's SIP consistent with current state rules. For ease of processing, EPA has divided this SIP amendment package into six parts: FL-173 (Removal of Obsolete and Redundant Rules), FL-174 (Removal of CAIR and removal of Rule 62-210.360 CAA 110(l) Noninterference), FL-175 (General Requirements Rule Amendments Miscellaneous Changes), FL-176 (Administrative Changes), FL-177 (Stack Height Policy) and FL-178 (Definitions).

Florida's State Implementation Plan (SIP) Rule 62-296.513, F.A.C. (Surface Coating of Miscellaneous Metal Parts and Products): Rule Amendments

On October 12, 2022, DEP submitted to EPA a Final Proposed SIP Amendment to Rule 62-296.513, F.A.C. ("Surface Coating of Miscellaneous Metal Parts and Products" [MMPP]). This proposed SIP revision consists of amendments that provide compliance alternatives to the MMPP requirements for aerospace parts and products coating operations by cross-referencing the requirements of the federal National Emission Standards for Hazardous Air Pollutants (NESHAP), 40 CFR Part 63, Subpart GG ("National Emission Standards for Aerospace Manufacturing and Rework Facilities"), adopted by reference in Rule 62-204.800, F.A.C. ("Federal Regulations Adopted by Reference").

EPA proposed approval of this SIP Revision in the Federal Register on July 30, 2024 (89 FR 61055). On September 27, 2024, EPA published a final rule in the Federal Register approving this SIP Revision (89 FR 79147), effective October 28, 2024.

Florida's State Implementation Plan (SIP) Chapter 62-204, F.A.C. ("Air Pollution Control – General Provisions"): Rule Repeals and Amendments

On August 12, 2022, DEP submitted to EPA a Final Proposed SIP Amendment to Chapter 62-204, F.A.C. ("Air Pollution Control – General Provisions").

For ease of processing, EPA divided this SIP amendment package into three parts: FL-168 (Administrative Changes); FL-169 (Delegations Actions); and FL-170 (General Conformity). This proposed SIP revision will remove outdated or superseded rule requirements in Chapter 62-204, F.A.C.

The proposed SIP revision will also incorporate recent amendments to rules in Chapter 62-204, F.A.C., to make Florida's SIP consistent with current state rules.

On January 12, 2024, DEP submitted to EPA two withdrawal letters to EPA, withdrawing portions of Rules 62-204.340 ("Designation of Attainment, Nonattainment, Unclassifiable, and Maintenance Areas"), and 62-204.500, F.A.C. ("Conformity"), as part of FL-169 SIP submittal. This was followed by a withdrawal letter for 62-204.320 (due to its references to 62-204.340) on March 5, 2024. Finally, DEP submitted a withdrawal letter for 62-204.360 on April 12, 2024, which closed out the FL-169 SIP submittal.

EPA published its proposed approval of FL-168 on May 15, 2024 (89 FR 42410) and a final approval on July 16, 2024 (89 FR 57734). On January 5, 2024, DEP submitted a partial withdrawal letter to EPA for some sections of 62-204.500 for FL-170. EPA then proposed approval of this submittal on February 1, 2024 (89 FR 6475), followed by a final approval on March 28, 2024 (89 FR 21437).

Florida's State Implementation Plan (SIP) Chapter 62-296, F.A.C. ("Stationary Sources – Emission Standards"): Rule Removals and Amendments

On April 1, 2022, DEP submitted to EPA a Final Proposed SIP Amendment to Chapter 62-296, F.A.C. ("Stationary Sources – Emission Standards"). This proposed SIP revision consists of the removal of outdated or superseded F.A.C. requirements under Chapter 62-296, F.A.C. The proposed SIP revision also incorporates amendments to F.A.C. rules to make Florida's SIP consistent with current state rules.

For ease of processing, EPA divided this SIP amendment package into five parts: FL-164 (Editorial Changes), which EPA proposed for final approval on November 6, 2023 (88 FR 76137) effective December 6, 2023); FL-165 (Substantive Changes), which EPA proposed for initial approval on November 28, 2023 (88 FR 83062) and, after DEP submitted a partial withdrawal letter for 62-296.320(3) on October 13, 2023, final approval on January 22, 2024 (89 FR 3886); FL-166 (Noninterference Demonstrations for Removal of Clean Air Interstate Rule and Obsolete Rules), which EPA proposed for final approval on October 3, 2023 (88 FR 67963, effective November 2, 2023); FL-167 (Non-Obsolete Rules – no action to date); and FL-167-1 (Miscellaneous Revisions to Chapter 62-296.500 [concurrent processing with Florida's Excess Emissions SIP]), which EPA proposed for final approval on August 4, 2023 (88 FR 51702, effective September 5, 2023). Final approval of FL-165 was found to be missing some rules originally proposed for approval and this matter has been brought to EPA's attention.

Florida's Proposed Regional Haze Plan for the Second Implementation Period

On October 8, 2021, DEP submitted to EPA Florida's final proposed Regional Haze Plan for the Second Implementation Period. (FL-163). This proposed SIP revision addresses regional haze in Florida's mandatory federal Class I areas and nearby Class I areas for the second implementation period under EPA's Regional Haze Rule. During the Federal Land Managers (FLM) consultation period, DEP received comments from the National Park Service noting that Florida's regional haze SIP has satisfied the reasonable progress requirements for Everglades National Park.
