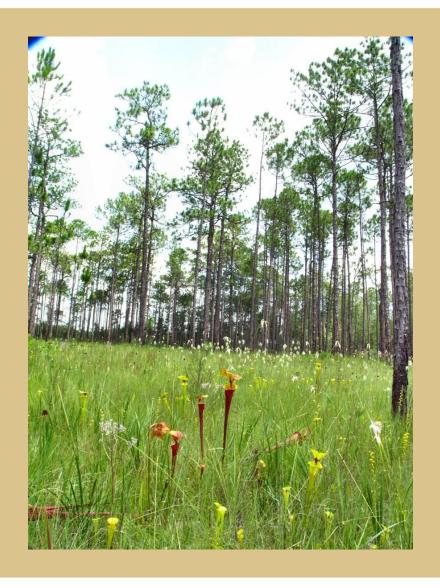

# The St. Joe Company Ecosystem Management Agreement and SAJ-RGP-86 Annual Report 2014

#### **SUMMARY**

In 2014, agencies and The St. Joe Company performed a review of all projects authorized under SAJ-86 / Ecosystem Management Agreement for the Army Corps of Engineers renewal process and the Florida Department of Environmental Protection 5 year review process. All projects are in compliance and the SAJ-86 2014 renewal is still in its review process with expectations to finalize in January/February 2015.

One authorization was issued in 2014 for Phase 3 of Breakfast Point Subdivision. All Pier Park North project impacts were finalized in 2014. The Pier Park Loop Road project was delayed in 2014 but some level construction may begin in 2015.

This report contains the project and sub-basin ledgers for all project authorizations issued through 2014. Devils Swamp Mitigation Bank Ledger and Breakfast Point Mitigation Bank Ledger are also included in this report.

### **2014 Projects**

#### **APPROVED PROJECTS**

Breakfast Point Subdivision – Phase 3 (ledger Item #23) was issued in January 2014 SAJ-86 Authorization No. SAJ-2013-02943(GP-LSL) and EMA authorization 03-0258023-013 in March 2014. In 2014, the on-site and off-site conservation easements were recorded and 13.03 FDEP credits and 13.16 ACOE credits were debited from Breakfast Point mitigation. Project impacts (20.03 acres of Low Quality and .015 acres of High Quality) began in 2014 and are planned to be impacted in sub-phases over the next 3 years.

### **2014 Project Ledger**

The Overall Projects ledger reflects all projects for which final authorizations have been granted, as of December 31, 2014. Through calendar year 2014, a total of 23 projects have received authorization within the SAJ-86 / EMA areas. While the majority of these projects have been completed, impacts authorized for West Bay Landings, Pier Park NW Hotel and Pier Park Loop Road have not yet been initiated.

Counting all impacts made through 2014, the Southwest West Bay sub-basin received 5.56% of low quality wetland impacts to date (2004 – 2014), however approximately 22 acres of low quality impacts have yet to be constructed. To date, the Highway 98 sub-basin has received 4.48% of low quality wetland impacts. The Phillips Inlet sub-basin has received 2.83% of total low quality wetland impacts to date. The Direct Runoff to Bay sub-basin has received 0.21% of total low quality wetland impacts through 2014.

The developable area (totals of all sub-basins, minus conservation units) total of low quality wetlands is now 6,796.60 acres. The developable area total of high quality wetlands is now 3,751.62 acres.

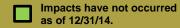

### **2014 Conservation Easements**

Conservation easements (on-site and off-site) were recorded in 2014 for Breakfast Point – Phase 3 as well as another area adjacent the SWWB CU for Pier Park Drive Extension (1.21 acres) and Pier Park Loop Road (.15 acres) projects per the 2014 RGP renewal.

Based on the EMA total possible developable acreage figure of 8,799 and total conservation unit acreage of 13,193, the ratio to maintain balance in the RGP-EMA area should be 1.5 acres of recorded conservation unit conservation easement for every 1 acre of project area. Currently, with 4,037.51 acres of recorded conservation unit conservation easement and 2010.78 project acres, the ratio is over-balance in favor of conservation unit acreage at 2.01:1.

#### **MITIGATION BANKS 2014**

Required land management activities including prescribe fire applications and control of nuisance exotic species (NEPs) continued in 2014 as required by the mitigation banking instrument (MBI) for Breakfast Point and Devil's Swamp Mitigation Banks.

- No credits were released in 2014 for either bank.
- A modification of the monitoring plan was approved by FDEP in 2014. The St. Joe Company is currently working with the IRT to modify the MBI with a similar monitoring plan and additional modifications to select success criteria and minimal administrative changes to both the MBI and FDEP permits.

#### Devil's Swamp:

- Prescribed burning occurred in December 2014 on 506 acres of Phase I. This burn was preceded by mechanical vegetation management in August 2014 that targeted 160 acres of selected wetland transition zones in Phase I.
- One culvert was replaced in Phase I and maintenance was performed on two low-water crossings (additional rock added) in Phase II. As-Built surveys for two low-water crossings also were completed.
- Small locations of NEPs (cogon grass) were treated on Steelfield and Bunker Roads (the northern boundary Devil's Swamp Phases I and II).

#### **MITIGATION BANKS 2014**

#### **Breakfast Point:**

- Prescribed fire was applied to 177 acres of Phase I with 723 acres still under contract to burn (as of January 15, 2015). A wildfire burned an estimated 131 acres in the northeast portion of Phase II in July, 2014. There are 392 acres of Phase II currently under contract to burn (as of January 15, 2015). Unburned areas under contract at the end of 2014 will be burned in 2015.
- No NEPs were treated in 2014. Removal of feral hogs continued in 2014, totaling 18 individuals by year-end.
- Two culverts were replaced in 2014 and an As-Built drawing for one low-water crossing was completed in 2014.
- Timber thinning occurred in 340 acres of Phases I and 614 acres in Phase II in 2014. Timber harvest operations targeted stands initially thinned in 2004 and 2005. The trees that remained following the initial thin either 'released,' forming larger canopies, or were in portions of thinned stands that were inaccessible by equipment due to ground conditions. The goal was to reduce tree densities to numbers identified as appropriate for each vegetative community type.

#### **OTHER MITIGATION 2014**

During 2014, required management activities continued within designated Conservation Units; specifically, portions of the Southwest West Bay, South American Swamp, and Lake Powell Headwaters Conservation Units:

Portions of the Southwest West Bay and Ward Creek CUs were clear-cut in 2014 following a prescribed burn that escaped containment from adjacent conservation lands owned by the Northwest Florida Water Management District. The Southwest West Bay mitigation area was prescribed burned in December 2014. Conservation Easement signage was placed on the perimeters of all current mitigation areas during 2014.

The off-site mitigation areas related to WaterSound North in Lake Powell Headwaters and Beach Commerce Park in South American Swamp and have been released to long-term management by both FDEP and ACOE. Final letters were received in 2014.
