FDEP will reach out to sponsor and inquire if roadkill mitigation was included as part of the project's design and engineering. Committee provided consensus that they would like to see this type of mitigation implemented into more projects. FDEP concurs and will consult with FDOT regarding wildlife crossing guidelines.*
- ii. *Committee inquired about how FDEP received additional funding for the 2019 Priority List (\$2.6M). FDEP provided belief that the funding came from FDOT's Transportation Alternative Program (TAP) but would request confirmation from FDOT.*

- i. Committee inquired about funding breakdown for FY20-21 and FY21-22. FDEP confirmed that no funding breakdown has been provided yet and it is uncommon for RTP to hold cycles every other year.
- ii. Committee inquired about the amount of funding for the FY21-22 application cycle. FDEP confirmed that the funding for FY20-21 will be available for projects during FY21-22, along with the funding provided for that application cycle. The project amounts cannot increase as they are set by the TAC, however with more funding for FY21-22, FDEP hopes to fund the entire Priority List.

FDEP intends to conduct outreach through the Florida League of Cities, Florida Association of Counties, and the Florida Recreation and Park Association to encourage all local government sponsors to apply for RTP funding.

FDEP anticipates hosting an application workshop webinar prior to the FY21-22 application cycle on February 1, 2021 through February 28, 2021. Committee requested notification and webinar information for the application workshop.
