SUBJECT: Transportation and Disposal of Additional Soil

DATE: September 13, 2017

In addition to the normal process for requesting costs related to the transportation and disposal of additional soil via Request for Change (RFC), it is understood that there are situations when overages may not be discernable until receipt of weight tickets. Therefore, it is the policy of the Petroleum Restoration Program that a request for approval of payment for additional Transportation and Disposal of soil identified via weight tickets is timely and may be authorized via RFC provided that the following criteria is met:

- 1) The RFC must be received by the site manager within two working days of the date the additional soil (overage) was transported from the site.
- 2) The volume of soil requested in the RFC does not exceed 20% of the total volume authorized in the Purchase Order.
